

RESOLUTION NO. 966

**A RESOLUTION OF THE BOARD OF COMMISSIONERS FOR THE APPROVAL
AND ADOPTION OF THE 2017 CHARGES AND FEE SCHEDULE**

WHEREAS, Kittitas County Public Utility District No. 1 maintains its facilities to enable the delivery of a safe, adequate and efficient source of electrical power. The Board of Commissioners is required to establish, maintain and collect rates (RCW 54.24.080) or charges for electric energy and other services supplied by the district; and

WHEREAS, the current loaded wage rates and equipment hourly costs were used to calculate the charges and fees on the attached schedule; and

WHEREAS, management has determined the 2017 charges and fee schedule is fair, nondiscriminatory and shall adequately provide revenues sufficient for the payment of principal and interest on revenue obligations and all payments which the district is obligated, including proper operation and maintenance of the utility; and

WHEREAS, management shall review and update charges and fees annually using comparable methodology.

NOW, THEREFORE, BE IT RESOLVED that the Commissioners of Kittitas County Public Utility District No. 1 approve the 2017 Charges and Fee Schedule.


